As this is not a Licence. Students from outside organisations may still be able to train within any of the British Wadokai Dojo available to them, without having to jeopardise their position on various 'Sport Karate' Governing-Body 'double-licencing' violations/restrictions, etc.

The Use of Temporary Visitors Membership.

Temporary Visitors' Membership is primarily for students who are visiting temporarily in the area, or just simply wish to train without being licenced, at a BWK Karate Club.

Restrictions: Non-licenced members will be unable to participate in; BWK Gradings, Advancement Opportunities, Instructing (whether temporary or permanent), Jiyu-Gumite (Dojo free-fighting), Shiai (all levels of Competitions, Championships & Tournaments, etc.).

Insurances - Cover is for all normal 'non-combatant' Wado Karate related activities organised within the UK membership of the British Wado Federation Governing Body. *Cover does not include training elsewhere and does not allow the use of live bladed weapons.*

Insurance.

United Kingdom National Benefits Insured: General Third Party Indemnity, Public Liability and Member to Member Liability; £10,000,000. For Full Synopsis, please refer to Master Policy. BWK Insurance Covers all ages.

A British Wadokai Insurance includes:

1. Registration & Membership to British Wadokai & British Wado Federation.
2. UK Person to Person Liability and Public Liability Insurance cover for £10,000,000.

Due to the turnover of student memberships in martial-arts it is usually considered that if a martial-arts licence has expired it is normally due to the result of the individual terminating training & membership etc. A student who allows his/her licence to expire will result in the following:

1. Registration card is destroyed after 7-days expiry.
3. Insurance cover becomes invalid **immediately at time of expiry.**
4. Membership terminated immediately at time of expiry.

Once reapplication has been accepted all records are replaced.
